Sesto San Giovanni, February 25th, 2019 - In compliance with the authorization approved by the Shareholder meeting held on April 23rd, 2018, mainly to be used to service the stock option plans, Davide Campari-Milano S.p.A. (LEI code 213800ED5AN2J56N6Z02) announces that between February 18th, 2019 and February 22nd, 2019 it bought back, on the regulated market (MTA) managed by Borsa Italiana, 108,670 own shares at an average price of € 8.2943 per share for a total amount of € 901,341.58.

The transactions have been executed by Goldman Sachs International (GSI), (LEI code W22LROWP2IHZNBB6K528).
