(LEI code 213800ED5AN2J56N6Z02) announces that between July 1<sup>st</sup>, 2019 and July 5<sup>th</sup>, 2019 it bought back, on the regulated market (MTA) managed by Borsa Italiana, 29,053 own shares at an average price of € 8.5929 per share for a total amount of € 249,649.52.
