Sesto San Giovanni, August 22nd, 2022 - In compliance with the authorization approved by the Shareholder meeting held on April 12th, 2022, mainly to be used to service of the Incentive plans based on financial instruments, Davide Campari-Milano N.V. (LEI code 213800ED5AN2J56N6Z02) announces that between August 16th, 2022 and August 19th, 2022 it bought back 23,179 own shares at an average price of € 10.2141 per share for a total amount of € 236,751,93.

The transactions have been executed by Morgan Stanley Europe SE, LEI Code 54930056FHWP7GIWYY08.
