MINUTES OF THE ORDINARY SHAREHOLDERS' MEETING OF DAVIDE CAMPARI-MILANO S.p.A. ON 19 DECEMBER 2017

The Ordinary Shareholders' Meeting of Davide Campari-Milano S.p.A., with registered office at 20, Via Franco Sacchetti, 20099 Sesto San Giovanni (MI), share capital of \in 58,080,000.00 (fully paid up), tax and VAT code and registration number in the Milan Companies' Register 06672120158, was held, in a single session, on 19 December 2017, at the premises of the Campari Academy at 23, Via Campari, to discuss and pass resolutions on the following

Agenda

1. Grant of the statutory mandate for the audit of the accounts for the years 2019-2027 and related resolutions.

At 9.30 a.m., in accordance with the law, the Articles of Association and the regulations, the Chairman of the Board of Directors, Luca Garavoglia, took the chair of the Ordinary Shareholders' Meeting, and proposed that Stefano Saccardi be appointed as meeting secretary and the officials of Computershare S.p.A. ('Computershare') as scrutineers.

No shareholder having objected, Stefano Saccardi and the officials of Computershare assumed the respective roles of meeting secretary and meeting scrutineers of the shareholders' meeting.

The Chairman stated that the Board of Directors was represented by the Chairman himself and members Robert Kunze- Concewitz, Paolo Marchesini, Stefano Saccardi, Eugenio Barcellona, Giovanni Cavallini, Camilla Cionini-Visani, Karen Guerra, Thomas Ingelfinger, AnnaLisa Elia Loustau and Catherine Gérardin Vautrin. The Chairman also stated that the entire Board of Statutory Auditors was present, i.e. Pellegrino Libroia (Chairman), Enrico Colombo and Chiara Lazzarini (statutory auditors).

The Chairman also confirmed that:

- pursuant to the provisions of law and the Articles of Association, the Ordinary Shareholders' Meeting had been duly convened via the notice published on the Company website on 10 November 2017, and, as an excerpt, in national daily newspaper *II Sole-24 Ore* on the same day;

- the meeting notice had also informed recipients that all documentation relating to the meeting prescribed under the legislation in force had been made available to the public through the publication on the Company's website, filing at the registered office and transmission to the authorised storage system 1Info (*www.1info.it*) on the same day, i.e. 10 November 2017, and the Board of Directors' report on the proposed agenda of the Ordinary Shareholders' Meeting had been published, pursuant to art. 125-*ter* of Legislative Decree 58 of 24 February 1998 ('TUF');

- shareholders in attendance at the Ordinary Shareholders' Meeting had been provided with a folder containing: (i) a photocopy of the meeting notice published in *II Sole-24 Ore* on Friday 10 November 2017; (ii) the Board of Directors' report on the proposed agenda of the Ordinary Shareholders' Meeting; (iii) the formal recommendation of the Board of Auditors of Davide Campari-Milano S.p.A. ('DCM'), pursuant to art. 13 of Legislative Decree 39 of 27 January 2010, for the grant of the statutory mandate for the audit of the accounts for the years 2019-2027; and the shareholders' meetings regulation; - that according to the information in the shareholders' register and the special list for double voting rights, supplemented by the notices received and other information available, the following shareholders directly or indirectly own stakes in excess of 3% of the capital ('capital' means the total number of voting rights):

- Alicros S.p.A.: 592,416,000 shares, or approx. 51% of the share capital, giving entitlement to 1,184,832,000 voting rights, or 64.37% of total voting rights;

- Cedar Rock Capital Ltd: 116,818,487 shares, or approx. 10.06% of the share capital, giving entitlement to 190,053,856 voting rights, or 10.33% of total voting rights;

- shareholders eligible to exercise voting rights did not issue a proxy to the Company's designated representative, pursuant to art. 135-*undecies* of the TUF;

- that questions had been received on the agenda item for the Ordinary Shareholders' Meeting pursuant to art. 127-*ter* of the TUF by Tommaso Marino.

The Chairman reminded the meeting that, pursuant to art. 11 of the Articles of Association and art. 83-*sexies* of the TUF, the right to take part in the Shareholders' Meeting was established via notification by the intermediary with which the shares were registered, in favour of the party to which – based on the accounting records on the seventh trading day prior to the date set for the Shareholders' Meeting – the voting right pertained, with the proviso that the Company had to be in receipt of this notification no later than 8 December 2017, although the individual would also be considered

entitled to vote if such notification arrived no later than the start of the meeting proceedings, in accordance with art. 83-*sexies*, para. 4 of the TUF. The Chairman confirmed that the Company had received no requests, pursuant to art. 126-*bis* of the TUF, to add items to the agenda.

The Chairman announced that the Shareholders' Meeting was duly constituted with 843 shareholders present, either in person or by proxy, representing 983,611,772 ordinary shares, equal to approx. 84.677% of total voting rights.

The Chairman reminded the meeting that, also pursuant to regulations approved by Consob, a list of the names of the participants present at the Ordinary Shareholders' Meeting, either in person or by proxy, with the statutorily required information, would be attached to the minutes.

To make it easier to record the meeting participants, the Chairman asked shareholders intending to leave the meeting before the end of the proceedings to kindly record their departure with the meeting officials and to hand back their forms at the appropriate table at the entrance to the hall. The Chairman also reminded shareholders that they had been given the forms that would be used to count the votes when they had entered the hall. In view of the above, the Chairman declared that the Shareholders' Meeting was duly constituted and that it could validly pass resolutions on the item on the agenda, and opened the floor for discussion as follows.

Regarding item 1 on the agenda

The Chairman reminded the meeting that the mandate for the statutory audit of the accounts granted to PricewaterhouseCoopers S.p.A. on 30 April 2010 would expire with the preparation of the consolidated and separate financial statements to 31 December 2018, thereby completing the maximum nineyear duration permitted by law. It would therefore be necessary to grant a new mandate for the years 2019-2027 to another auditing firm.

The Board of Directors deemed it appropriate to submit the proposal to the Shareholders' Meeting before the expiry of the mandate currently in force, since granting the new mandate early would help ensure a smoother handover, and is also in keeping with the provisions of art. 5 of EU Regulation 537/2014, which introduced a cooling-in period, whereby a statutory auditor cannot be appointed to perform the audit if, during the year prior to the beginning of the financial period to be audited, that auditor has provided certain specified non-audit services.

In this regard, the Chairman briefly summarised (i) the Board of Directors' report on the proposed agenda of the Ordinary Shareholders' Meeting, (ii) the formal Recommendation of the Company's Board of Auditors, pursuant to art. 13 of Legislative Decree 39 of 27 January 2010 and art. 16 of EU Regulation 537/2014 relating to the granting of the mandate for the statutory audit of the accounts for the years 2019-2027, (iii) the procedure for selecting the auditing firm laid down by the above-mentioned recent legislation, which led to the choice of Ernst & Young S.p.A. ('E&Y') and (iv) the financial terms and conditions of the proposal.

Before the voting commenced, the Chairman read the questions received from shareholder Tommaso Marino on 16 December 2017 and gave the relevant answers. 1) How much has the cost of the external audit mandate increased compared with the remuneration paid to PricewaterhouseCoopers ('PwC')? E&Y's fees will be around € 550,000 less per year, assuming the same scope of activities and work carried out.

2) Which auditors from the auditing company work in Gruppo Campari or have a mandate from it? There are no employment contracts between DCM and PwC. 3) What would the costs have been for KPMG S.p.A., since the Board of Auditors is proposing E&Y on financial grounds? \in 59,000.00 per year, i.e. \in 531,000 for the nine-year mandate. 4) Do the members of the Board of Auditors and/or Board of Directors have any consultancy agreements with E&Y? No. 5) Do the members of the Board of Auditors and/or Board of Directors have any consultancy auditors provide the incoming firm with a handover file? The outgoing auditors will ensure a smooth handover. 7) Who is the auditing firm controlled by in Europe and in Italy? The question is not relevant. 8) Is the contract with the new auditing company linked to results obtained? No.

9) In European regulatory terms, is Campari considered a public interest entity? Yes. 10) Will the auditing company be required to provide tax advice and/or consultancy services relating to internal audit under the mandate? The current tax consultancy work has been awarded in compliance with applicable legislation. It is possible that tax work may be assigned after the termination of PwC's mandate for the statutory audit, but it will also comply with applicable legislation. In accordance with recent legislation on the statutory audit of accounts, tax duties carried out by E&Y will cease when the mandate expires. 11) To which authorities will the contract signed by the auditing company be submitted? It will be subject to any checks laid down by law. 12) Does E&Y have links with the Isle of Man? The question is not relevant. 13) In choosing E&Y, was the Board of Directors influenced by the fact that, according to the press, this company paid € 5,000 a month to one of its former consultants, now an advisor to the Italian Finance Minister, to pass on confidential information? The choice was not influenced by the above-mentioned facts, not least because the selection was made before the press articles about these facts were published. 14) Are you aware that both Marco Ragusa, a representative of EY in Italy, and the auditing company that he represents, are to be investigated for bribing Susanna Masi, the above-mentioned advisor to the minister Pier Carlo Padoan? Yes. We would like to specify that, as far as we understand, Mr Ragusa's activities were supplied via a law firm (Studio Legale Tributario, 'SLT', a professional association under Italian law), which although part of the E&Y network, is a separate and autonomous entity, and that the services provided by E&Y to DCM are not in any way connected with the facts being investigated. 15) Why were these issues not addressed by the Board of Auditors and the Board of Directors? These facts were not considered to be relevant for the above reasons, also bearing in mind that the selection took place before they occurred. 16) Do you think it appropriate to grant the mandate to this company, despite the revelations in Il Corriere della Sera, without being afraid that Gruppo Campari could lose credibility? Yes. 17) If the auditing company and/or its

representative were to be convicted, would Campari terminate the contract or would it strengthen it? The legal conditions would not allow us to terminate the relationship. 18) Has Campari obtained any information on whether E&Y has completed its internal investigation – which it said it would carry out to ascertain the facts – and considers it extraneous to the matter in hand? We did not consider it relevant to obtain information about an investigation into facts that are extraneous to today's issue of granting the mandate. 19) It seems that the new information E&Y wanted to find out from the alleged spy related to tax matters. What kind of relationships has Gruppo Campari had with this company so far? We have granted mandates to it to do what? At the moment we have mandates in place with E&Y for IT consultancy services, and for assistance in complying with the local tax regulations of overseas countries in which Group employees work. 20) Has the Chairman of Campari and/or any of his close family obtained consultancy advice from E&Y? If so, what type? No. 21) Which senior managers will examine these questions? The General Counsel and Business Development Officer and the Investor Relations & Corporate Finance Director.

The Chairman then opened the floor for discussion of the item and, since no request to speak was made, the proposal to grant the mandate to E&Y for the statutory audit of the accounts of DCM, with a nine-year duration, pursuant to law, for the years 2019-2027, and entailing an annual payment of \in 395,000.00 was put to the vote.

After the vote had taken place, the Chairman declared the proposal in question approved by a majority, with the following votes: 1,661,160,493 in

favour, or 99.998% of the voting rights attached to the ordinary shares represented (approx. 90.260% of the total voting rights); no votes against, 29,448 abstentions, or approx. 0.002% of the voting rights attached to the ordinary shares represented (approx. 0.003% of total voting rights).

Since there were no other items on the agenda and no other requests to speak, the Chairman thanked the meeting participants and declared the Shareholders' Meeting closed at approximately 9.45.
